I covenant and agree that by signing this release, I am waiving all known and unknown risks of harm, including but not limited to, the risk of running near vehicular traffic, running on a sidewalk, running on a trail, running through water, running through woods, getting lost, falling, personal harm or death due to the length of the run, other runners, inclement weather, trail/road/sidewalk conditions, wildlife/animals, and failure to abide to all traffic/crosswalk laws.

I know that running a road race is a potentially hazardous activity that could cause injury or death. I should not enter and run unless I am medically able and properly trained, and by my signature, I certify that I am medically able to perform this event, am in good health, and am properly trained. I agree to abide by any decision of a race official relative to any aspect of my participation in this event, including the right of any official to deny or suspend my participation for any reason whatsoever.

I hereby agree that in the event any claim arising out of our incidental to personal injury or damages to me shall be filed against the Released Parties, I shall indemnify and hold harmless such Released Parties against any and all such claims, including attorney's fees incurred by Extreme Design Concepts, LLC or The Friends of Devils Den State Park, Inc. in defending any such claims.
